AS ALAMEDA COUNTY'S CENTRAL CLEARINGHOUSE FOR DONATED, SURPLUS AND PURCHASED FOOD FOR NONPROFIT AGENCIES, THE FOOD BANK DISTRIBUTED 32 MILLION POUNDS OF FOOD INCLUDING 17.8 MILLION POUNDS OF FRESH FRUITS AND VEGETABLES IN THE 2015 FISCAL YEAR.
