ALLEVIATING CHILDHOOD HUNGER THROUGH CALFRESH PARTNERSHIPS

In Alameda County, an estimated 19.4 percent of households are living in poverty. And with a food insecurity rate of 20.7 percent for children, approximately 70,680 children face the threat of hunger each day.

Last May, ACCFB, ACSSA, Alameda Health Consortium and other community agencies focused on enrolling eligible families in CalFresh through a CalFresh Awareness Month campaign called "Connecting Kids to CalFresh."

The campaign aimed to address food insecurity by promoting the CalFresh Program to families with children, and by providing them with resources to apply for benefits, with an emphasis on increasing health and nutrition awareness. There were events held across the county, and some of the participating agencies included LifeLong Medical Care, Tri-City Health Center and WIC programs.

"We researched the amount of CalFresh benefits the households we assisted could receive, and it was rewarding to see the tremendous impact these extended food dollars will have on these low-income families,"said Njeri McGee-Tyner, eligibility and enrollment director at Alameda Health Consortium.

Together, we can support families and improve the health and well-being of all children.
