ARTICLES OF INCORPORATION

THE FOOD BANK NETWORK OF ALAMEDA COUNTY, INC.

The name of this corporation is The Food Bank Network of Alameda County, Inc.

II

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

#### III

- The PRIMARY PURPOSE of this corporation is to operate a network of service organizations for the distribution of food and goods to the poor and needy of Alameda County through nonprofit corporations.
- The general purpose of this corporation is to aid, develop, promote, direct, sponsor, foster, and advance the distribution of food and goods to the poor and needy of Alameda County.
- The corporation shall not engage in any C. activity or exercise of power that is not in furtherance of the purposes of this corporation.

IV

The name and address in the State of California of this corporation's initial agent for service of process is:

V

- A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

VI

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a

nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

VII

The PRINCIPAL OFFICE of this corporation shall be located in the County of Alameda, State of California, U.S.A.

VIII

The DIRECTORS and OFFICERS shall be chosen in accordance to the Bylaws.

IX

MEMBERSHIP shall be established in accordance to the Bylaws. The ultimate authority over the Network's membership rests with the Board of Directors.
